**Circular R&C-CFA No. 55/12-13**

**Subject: Revision in charges under Annual Payment Option for all the ADSL postpaid Broadband Plans in Odisha Circle – reg.**

CGM Odisha circle may kindly refer to his office letter no. CFA-OR/PMSM-004/2012-13/45 dated 27-11-2012 regarding suggestions and proposals for rationalization of Broadband Tariff in Odisha circle.

2. The proposal has been examined in this office and **Competent Authority has decided to revise the charges under Annual Payment Option for all the ADSL postpaid broadband plans in Odisha circle as follows:-**
  - a. ***For the new Broadband customers in Odisha Circle, the Annual Payment Option under ADSL Postpaid Broadband Plans shall be offered by levying Fixed Monthly Charges of 11 months only for the service of one year.***
  - b. ***For the existing BB customers in Odisha Circle, who are already under Annual Payment Option with 10 months rental scheme, they may not be charged the extra 1 month rental till the expiry of their current annual subscription.***
3. All other relevant terms and conditions, as mentioned in earlier circulars, shall remain unchanged.
4. These instructions shall **be effective w.e.f. 01-02-2013 in Odisha circle only.**
5. This circular is issued based on the approval of Competent Authority in Broadband cell file No. 64-03/2009-BB/.
