**Subject: Promotion of Broadband services – concessions to prospective customers – reg.**

The Competent Authority has decided to allow the following concessions for a period of 90 days for promotion of Broadband service of BSNL to prospective customers.

1. **Security Deposit for Broadband** (as applicable for the Opted plan) shall be taken in three equal monthly installments starting from the first bill.
2. **Modem Security Deposit** (in case Modem is taken on rental basis from BSNL) shall be taken in three equal monthly installments starting from the first bill.

The above concessions shall be applicable for New Broadband customers only and the offer shall be valid for 90 days only with immediate effect.

All other terms and conditions currently applicable to New Broadband applicants shall remain the same.
