**Sub: Introduction of F&F feature in "Student special" plan-reg.**

To

**All CGMs- Telecom Circles/ Telephone Districts**


Kindly refer to this office letter of even no. dated 16.06.2016 and clarifications issued vide letter dated 26.06.2016 and orders issued from time to time with regard to tariff under Student Special Plan under prepaid mobile services. Now competent authority has decided to allow addition of F&F features in Student Special Plan as under-

**A. Addition of F&F features in Student Special Plan-**

- i. The F&F facility with Student special plan for two local numbers (Mobile/LL/ GSM/CDMA) ( on-net/off-net)" with tariff of 10p/min for local on-net F&F number and 20p/min for local off-net local F&F number.
- ii. The F& F number can be any combination of on-net/off-net local numbers.
- iii. Registration of each F&F number/ change of each F&F number will be charged @Rs.5/change or Rs.5/registration.
- iv. The tariff offered for F&F number will be applicable in home LSA only. If number under student special plan is in roaming then base tariff will be applicable for calling to F&F number also i.e. no reduced tariff of 10p/min for local on-net F&F number and 20p/min for local off-net local F&F number.

**B. Allowing of STV88 and STV42 for student special plan also with only "minute" pulse option.**

2. These features to be implemented **w.e.f 20/07/2016**. All the other terms and conditions will remain same.
3. The implementation of the tariff is to be made in accordance with 43rd Amendment of Telecom Tariff Order and orders/guidelines/clarifications issued by TRAI from time to time.
4. This may be brought to the notice of all concerned for taking necessary action in this Regard. Press note and proper advertisement as deemed fit may be made. Circles may also send SMS conveying the above tariff to the customers.
5. Circles have to update their website and report the same to TRAI as per tariff reporting requirement of TRAI.
6. This circular is issued based on the approval of ECT vide Approval No.2402 dated 06.07.2016 in P&P-CM Cell file No.3-38/ECT/2015/P&P-CM(Pt.I). Queries/clarification/ feedback in respect of above tariff may be addressed to Product and Pricing- CM Section, C.O., BSNL, New Delhi.
