Sub: Introduction of (a) VVoBB-350L & VVoBB-2200U as promotional plans for a period of 90 days (b) Multiple VVoBB connections (any-mix of plans) on single broadband connectivity.

Ref: 1) 1-1/2012-R&C [CFA] dated 30-4-2012 (circular no. 03/12-13)

A. VVoBB-350L & VVoBB-2200U as promotional plans for a period of 90 days.

1. The approval of Competent Authority is hereby conveyed for Introduction of VVoBB-350L & VVoBB-2200U as promotional plans for a period of 90 days having all India calling scope (including MTNL) with details as below:

2. On the FMC, revenue shareable with franchisee M/s SIS shall be on Rs 200 for VVoBB-350L plan & on Rs. 2050 for VVoBB-2200U Plan. FMC amounting Rs 150/- which includes monthly service charges for PVC, etc shall be retained in full by BSNL.
3. Revenue for International Non-Video calls shall be shared as per agreement.
4. The rates indicated are exclusive of service tax which shall be charged extra as per prevailing tariff. IUC/carrier charges (if any) shall be applicable as per the TRAI guidelines.
5. **All other relevant terms and conditions including levies etc shall be as per the earlier circulars in vogue.**
6. This circular is issued based on the approval of Competent Authority in IT & BB-VAS cell file No. 14-1/2012-Broadband/IT-CFA/Pt. 7. These plans mentioned in Para 1 above shall be effective from 01-02-2013 for a period of 90 days on promotional basis in all the circles of North & West zone.

B. Multiple VVoBB connections on single broadband connectivity –

Customers shall have flexibility to avail any of the available VVoBB plans – **any mix of Basic, 750, 350 or 2200 etc.** on their single broadband connectivity. However, monthly service charges for VPN, etc for 2nd connection and onwards shall be halved (i.e., Rs 75).
