**Circular R&C-CFA No.149/18-19**

**Subject: Introduction of PAN India Broadband plan 'Experience Unlimited Broadband 299' & withdrawal of Circle Specific Broadband plan 'BBG Combo ULD 399 CS268' in Vadodara SSA of Gujarat Circle-reg.**

1. CGMT Gujarat may kindly refer to his office proposal vide letter no. MKTG-CFA/Tariff Committee-II/2018-19/29 dated 20-11-2018 to allow plan 'Experience Unlimited Broadband 249' and withdrawal of 'BBG Combo ULD 399 CS268' in Vadodara SSA of Gujarat.
2. The proposal has been examined by the tariff committee and following has been decided by the Competent Authority:
  - a) **To introduce the PAN India Broadband plan 'Experience Unlimited Broadband 299' [as revised from 'Experience Unlimited Broadband 249' vide letter No. 1-1/2018-R&C (CFA) (Circular R&C-CFA No. 146/18-19) dated 26-11-2018] on regular basis in Vadodara SSA of Gujarat.**  
**Revision under FMC/Bandwidth/Free calling facility as per above mentioned circular, shall be applicable for all the existing as well as new customers.**  
**All other terms and conditions shall remain same as per above mentioned circular.**
  - b) **To withdraw Circle specific Broadband plan 'BBG Combo ULD 399 CS268' for new customers in Vadodara SSA of Gujarat.**  
**Existing customers under above FTTH Broadband plan shall continue. However, efforts may be made to migrate these customers to some other DSL/FTTH Broadband plans.**
3. The Circles shall ensure to comply with all regulatory mechanism **including online reporting to TRAI and also update the Circle website.**
4. These instructions shall **be effective with immediate effect on regular basis in Gujarat Circle only.**
5. All other terms and conditions shall remain unchanged.
6. This circular is issued based on the approval of Competent Authority in Broadband Cell File No. 64-446/2018/BB/Tariff.
