4. *It should be ensured by the Circle that above plans are offered in only those locations/colonies of in Faridabad SSA where there is a matching competition from private operators.*
5. **The Circle shall ensure to comply with all regulatory mechanism and also update the Circle website.**
6. All other terms and conditions shall remain unchanged.
7. These instructions shall be effective w.e.f. 21-07-2016 in Faridabad SSA of Haryana Telecom Circle only on promotional basis for 90 days.
