**Subject: Re-launch of add-on voice packs for offering 24 hrs. Unlimited free calls (Local + STD) to any network under broadband combo plans in selected SSAs-reg.**

1. CGMT MP, Haryana & Rajasthan may kindly refer to his office proposal vide letters No. GM (S&M)/CFA-Mktg/BB Proposal/03-05/88 dated 06-07-16, Coml./HR/PP-I/LL Tariff Proposal/19 dated 06-07-2016, GM/CFA/JP/Action Points/2016-17/28 dated 06-07-2016 respectively, for seeking approval for extension of add-on voice packs for offering 24 Hrs. unlimited free calling (local+STD) to any network under Broadband Combo Plans.

The proposals have been examined in this office and the competent authority has decided **to re-launch Add-on voice packs [as introduced vide letter no. 1-1/2015-R&C (CFA) {Circular R&C-CFA No. 185/15-16} dated 17-03-2016 and revised vide letter No. 64-384/2016/BB/Tariff dated 02-06-2016] for offering 24 hrs. Unlimited free calls (Local + STD) to any network under broadband combo plans in following SSAs on promotional basis for 90 days:**
  - a) *Jaipur SSA of Rajasthan Circle.*
  - b) *Faridabad & Gurgaon SSAs of Haryana Circle.*
  - c) *Bhopal, Indore, Jabalpur & Gwalior SSAs of MP Circle.*
3. The Circles shall ensure to comply with all regulatory mechanism and also **update the circle website.**
4. These instructions shall **be effective with immediate effect on promotional basis for a period of 90 days in Jaipur SSA of Rajasthan Circle, Faridabad & Gurgaon SSA of Haryana Circle, Bhopal, Indore, Jabalpur & Gwalior SSAs of MP Circle only.**
5. ***All other terms and conditions shall remain same as per earlier circulars.***
