**Subject: Revision under existing Circle Specific Broadband plans 'Fibro Combo ULD 1499 CS29', 'Fibro Combo ULD 2490 CS36' and withdrawal of Broadband FTTH plans 'Fibro Combo ULD 3999 CS297', 'Fibro Combo ULD 5999 CS298' & 'Fibro Combo ULD 9999 CS299' in Odisha Circle-reg.**

1. CGMT Odisha Circle may kindly refer to his office proposal letter No. CFA-OR/PMSM-004/2017-18/153 dated 20-07-2018 for seeking approval for revision under some Circle Specific Plan, closure of some Circle Specific Plans & introduction of new Circle Specific Plan alongwith some PAN India plan in Odisha Circle.

2. The proposal has been examined in this office and the Competent Authority has decided **as follows:**

a) **To revise Circle specific FTTH Broadband plans 'Fibro Combo ULD 1499 CS29', 'Fibro Combo ULD 2490 CS36' for all the existing/new customers in Odisha Circle as follows:**

Plan Name	Existing Bandwidth (Download Speed)	Revised Bandwidth (Download Speed)
Fibro Combo ULD 1499 CS29	Upto 15 Mbps till 100GB, upto 2Mbps beyond	Upto 20 Mbps till 200GB, upto 2Mbps beyond
Fibro Combo ULD 2490 CS36	Upto 20 Mbps till 250GB, upto 2Mbps beyond	Upto 30 Mbps till 300GB, upto 2Mbps beyond

b) **To withdraw Circle Specific FTTH Broadband plans 'Fibro Combo ULD 3999 CS297', 'Fibro Combo ULD 5999 CS298' & 'Fibro Combo ULD 9999 CS299' for new customers in Odisha Circle.**

**Existing customers under above FTTH Broadband plans shall continue. However, efforts may be made to migrate these customers to some other DSL/FTTH Broadband plans.**

3. The Circle shall ensure to comply with all regulatory requirements **including online reporting to TRAI and also update the Circle website.**

4. All other relevant terms and conditions, as mentioned in earlier circulars, shall remain unchanged.

5. These instructions shall **be effective with immediate effect on regular basis in Odisha Circle only.**
