**Subject: Withdrawal of Circle Specific Broadband plan 'BBG 390 CS19' in Karnataka Telecom Circle - reg.**

1. CGMT Karnataka Circle may kindly refer to his office proposal vide letter no Mktg. CFA/28/Corp Tariff/LL-BB-FTTH-PCO/61 dated 19-10-2017 for seeking approval for withdrawal of Circle specific broadband plan 'BBG 390 CS19' in Karnataka Circle.
