Sub: Revision in tariff for Bulk push SMS service –reg.

Kindly refer to this office order of even No. dated 11.01.2013, 24.01.2013, 04.06.2013 and orders/clarifications issued from time to time on the subject mentioned above. Now based on feedback received from field units it has been decided by the Competent Authority to revise/modify the bulk push SMS tariff as under:-


- i) Discounting powers delegated to CGMs have been increased from 1p/SMS to 2p/SMS on card rate for Bulk Push SMS.
 - ii) Bulk push SMS tariff will be applicable to M-Governance projects also.
 - iii) The transactional SMS send by/for Government agencies are to be restricted to On-net transactional SMS only and no Off-net transactional SMS is to be allowed. The rebate of 5p/SMS on transactional SMS send by/for Government agencies are applicable on On-net SMS.
2. All other terms and conditions will remain the same.
 3. The above tariff will be implemented with effect from **08.08.2013**.
 4. This circular is issued based on the ECT approval No.1231 dated 31.07.2013 in P&P-CM cell File No. 3-38/2010-P&P-CM (Pt.II).
