 - ii. Size of Centrex Group: **Minimum 400 (four hundred) Centrex Connections or more.**
 - iii. Centrex charges per DEL per month: **Nil**
 - iv. All calls free within the Centrex group.
 - v. Call charges : **No outgoing calls allowed**
 - vi. Installation charges: **Nil**
 - vii. Agreement will be made with Owners Association and bills will be paid by **RWA** for Centrex facility.
 - viii. All other terms and conditions as per General Landline plan rules.
3. **The Circles shall ensure to comply with all regulatory mechanism including online reporting to TRAI and also update the Circle website.**
4. **The above instructions are effective after three days from the date of issue of this circular i.e. 16-02-2019.**
