Sub:- Introduction of a scheme to waive off ONT rental charges under FTTH Broadband plans in all the Circles -reg.

1. The Competent Authority has decided to introduce a scheme for waiver of monthly rental charges of Rs. 90/- for FTTH ONT (when ONT is taken on rent from BSNL) in all the Circles for a period of Six months, only to the new FTTH BB customers who opt FTTH BB plan with FMC Rs. 599/- & above.
2. The Circles shall ensure to comply with all regulatory requirements.
3. The above instructions shall be applicable with immediate effect for a period of Six months in all the Circles.
4. All other terms and conditions shall remain the same.
