
Subject: Introduction of new FTTH Broadband plans 'Fibro Combo ULD 891 CS264', 'Fibro Combo ULD 1091 CS265' and 'Fibro Combo ULD 1291 CS266' on promotional basis in Gurgaon SSA of Haryana Circle - reg.


