Circular R&C-CFA No. 66/13-14

**Subject:- Introduction of MOU based Tariff in Universal ITC (UITC) & Extension of shelf life**

Kindly refer to this office circular No. 3-1/2010-R&C [CFA] dated 04.07.2013 (Circular R&C-CFA No. 22/13-14) wherein tariff of UITC was changed from Paisa/Sec. to Rs/Minute (MoU) with 60 second pulse.

It may be noted that as per clause 5 of above, it was communicated, "Existing tariff (paisa/second) shall continue for cards/e-PINs already generated/ printed and in circulation either at BSNL /distributor or customer end. "Validity of such cards i.e. cards / e-PINs already generated/ printed and in circulation either at BSNL /distributor or customer end, shall not be extended beyond expiry of life period". This matter has been further examined in this office and it **has been decided to modify the said clause as follows:**


1. Tariff of UITC from **Paisa/Second to Rs/Minute (MoU based)** may be changed for those cards/e-PINs available with **BSNL and franchisees for which request has already come to SCP Incharges/BSNL CO or request will come for shelf life extension henceforth.** This shelf life extension will be as per guidelines of BSNL CO issued vide circular No. 24-02/2012/NWO-CFA dated 26.02.2013 & 24-02/2012/NWO-BB & IN dated 12.07.2013.
2. SCP Incharges shall take necessary action in this regard whenever they receive any request for extension of shelf life from any circle.
3. This new tariff shall also be applicable to all cards/e-PINs to be generated/printed. This has already been conveyed and is effective from 15.07.2013 as per BSNL CO letter dated 04.07.2013.
4. The other terms and conditions/guidelines including Card Value/ Talk value shall remain unchanged.
