A number of Trunk Alignments earlier used for inter-city/exchange junction working have heen rendered spare due to conversion of media to reliable technologies. These spare alignments Are prone to theft, hence, it has been decided that the spare trunk alignments which are not under Mily use and no further use is envisaged for them may be scrapped and disposed off as per

- Following two options are suggested for disposal of such alignments:
 - The whole alignment including all components i.e. wires, poles etc. may be scrapped & disposed off on 'as is where is basis 'through tender or through MSTC. (11)
 - The wires may be recovered through tender and disposed off through MSTC. The poles may be disposed off on 'as is where is basis' through tender or through

A decision may be taken locally by the GMTD or Area G.M for selecting the option depending upon the local conditions like condition of the alignment, quantity of wire available on the Althorne and which option is going to be more suitable financially.

Allgaments lying unused in the local telephone systems with no possibility of utilization in Mar future may also be disposed-off in a similar manner.

A limited number of posts, wires and other material in good condition can be retained if ound to be useful for erection of DPs or extending DELs or any other use.
