Circular R&C-CFA No. 19/09-10

Subject: Provision of New CDMA VPT connections on prepaid basis (without any charge for the instrument) and conversion of Closed/DNP/Faulty landline VPTs into Prepaid CDMA VPTs – reg.

The proposal on the subject received in this office has been examined and approved by the Competent Authority with certain modifications. Accordingly, the approval of Competent Authority is hereby conveyed as follows:

1. **Provision of New VPT connections:**

New CDMA VPT connections on prepaid basis shall be **provided free of cost (i.e. without any charges towards the sale price of FWT instrument), in the areas where front loaded subsidy of Rs. 25000/- (Rs. Twenty five thousand only) is receivable under USOF.** At other places the existing instructions issued vide circular No. 24-2/2009-R&C dated 01.06.09 (Circular R&C No. 29/09-10) regarding recovery of sale price for FWT instruments shall apply for provision of Prepaid CDMA VPT connections.

2. **Conversion of Closed/DNP/Faulty Landline VPTs into Prepaid CDMA VPTs :**

The existing Closed/DNP/Faulty Landline VPTs can be converted into prepaid CDMA VPTs, free of any conversion charges and without any charges towards the sale price of FWT instrument. However, other Commercial guidelines as prescribed for conversion of CDMA Post Paid VPTs to CDMA Prepaid VPTs issued vide **circular No. 115-12/09-Comml. dated 19.06.09** shall apply on similar lines for conversion of above mentioned Landline VPTs to Prepaid CDMA VPTs also.

3. In both the cases mentioned at 1 & 2 above **Prepaid CDMA VPTs shall be provided with STD facility.**

4. **Tariff for the above mentioned Prepaid CDMA VPTs shall be governed by the existing instructions issued on tariff for Prepaid CDMA VPTs circulated vide letter No. 24-2/2009-R&C dated 01.06.09 (Circular R&C No. 29/09-10) and letter No. 24-2/2009-R&C dated 19.11.2009(Circular No. 94/09-10).**

5. This circular is issued based on the approval of Competent Authority in RN Cell file No.20-4/2009-RD/VPT Prepaid (Pt.). The impact of this tariff may be analyzed and feedback submitted on monthly basis to RN cell of BSNL CO under GM (RN), on Fax No. 011-23723589 and T&C-CFA cell on Fax No. 011-23734322 and at tcfa.bsnl@gmail.com.

6. The above instruction shall have **the immediate effect.**

7. **With the issue of the above instructions, the Circular R&C-CFA No. 18/09-10 on the same subject issued vide letter of even No. dated 04.01.2010 stands withdrawn.**
