Subject: Re-launch of Broadband plans 'BB Combo ULD 1091 CS169', 'Fibro ULD 1045 CS48' & 'Fibro ULD 1395 CS49' in selected SSAs of Kerala Circle on regular basis -reg.

1. CGM, Kerala Telecom Circle, may kindly refer his office letters vide No. CGM-Mktg./10-23/ECT-01/2016-17/25, CGM-Mktg./10-23/ECT-02/2016-17/21 & CGM-Mktg./10-23/ECT-03/2016-17/21 dated 10-11-2016, seeking approval for extension of 'BB Combo ULD 1091 CS169', 'Fibro ULD 1045 CS48' & 'Fibro ULD 1395 CS49' respectively in selected SSAs of Kerala Circle.
2. The proposal has been examined by the CFA Tariff Committee and following has been decided by the Competent Authority:
 - a) *To re-launch Broadband plan 'BBG Combo ULD 1091 CS169' [as introduced vide letter No. 1-1/2016-R&C (CFA) {Circular R&C-CFA No. 99/16-17} dated 08-08-2016] on regular basis in Trivandrum, Ernakulam, Trissur & Kozhikode SSAs of Kerala Circle only.*
 - b) *To re-launch FTTH Broadband plan 'Fibro ULD 1045 CS48' & 'Fibro ULD 1395 CS49' [as introduced vide letter No. 1-1/2016-R&C (CFA) {Circular R&C-CFA No. 99/16-17} dated 08-08-2016] on regular basis in Trivandrum, Ernakulam, Trissur, Palakkad & Calicut SSAs of Kerala Circle only.*
3. *The Circle should ensure that above plans are offered in only those locations/colonies of above SSAs where there is a matching competition from private operators.*
4. The Circle shall ensure to comply with all regulatory mechanism **and also update the Circle website.**
5. All other terms and conditions shall remain unchanged.
6. These instructions shall **be effective w.e.f. 01-12-2016 in selected SSAs of Kerala Circle as above on regular basis.**
7. This circular is issued based on the approval of Competent Authority in Broadband cell file No. 64-404/2016-17/BB/Tariff.
