**Circular R&C-CFA No. 182 /16-17**

**Subject: Re-launch of Broadband plans 'BBG Combo ULD 695 CS184' and 'BBG Combo ULD 875 CS185' and 'BBG Combo ULD 995 CS186' on regular basis in selected SSAs of AP & Telangana Telecom circles -reg.**

1. CGM, AP Telecom Circle, may kindly refer his office letters vide No. TA/Com-I/Tariff BB/2016-17/38 dated 14-12-2016, seeking approval for for regularization of BB plans 'BBG Combo ULD 695 CS184' and 'BBG Combo ULD 875 CS185' and 'BBG Combo ULD 995 CS186' in selected SSAs of AP & Telangana Telecom Circles.
2. The proposal has been examined by the CFA Tariff Committee and following has been decided by the Competent Authority:
  - a) *To relaunch BB plans 'BBG Combo ULD 695 CS184' and 'BBG Combo ULD 875 CS185' and 'BBG Combo ULD 995 CS186' [as introduced vide 1-1/2016-R&C (CFA) {Circular R&C-CFA No. 119/16-17} dated 02-09-2016] on regular basis in Tirupati, Kurnool, Ananthpur, Warangal, Khammam, Ongole, Karimnagar, Cuddapah, Mahaboobnagar, Nizamabad, Nalgonda, Adilabad, Srikakulam & Vizianagaram SSAs of AP & Telangana Telecom Circles.*
  - b) *The SUNDAY free calling facility is also available under above plans, as clarified vide letter No. 64-359/2015/BB-Misc. dated 22-11-2016.*
  - c) *Since all the DSL plans are available on FTTH with same tariff, the above BB plans shall also be available on FTTH with same tariff.*
3. *It should be ensured by the circle that above plans are offered in only those locations/colonies of above SSAs of AP & Telangana Telecom Circles where there is a matching competition from private operators.*
4. The circle shall ensure to comply with all regulatory mechanism **and also update the circle website.**
5. All other terms and conditions shall remain unchanged.
6. These instructions shall **be effective with immediate effect on regular basis in selected SSAs of AP & Telangana Telecom circles as above.**
7. This circular is issued based on the approval of Competent Authority in Broadband cell file No. 64-402/2016-17/BB/Tariff.
