**Circular R&C-CFA No. 35/14-15**

**Subject:- Revision of ISD tariff for Landline PCOs / FLPP PCOs / WLL (Fixed) PCOs / VPT (Fixed) PCOs – reg.**

A kind reference is invited to this office letter No.3-1/2010-R&C (CFA) dated 12-02-2014 (Circular No.94/13-14) conveying approval of the Competent Authority for revision of ISD tariff for the PCOs for the destinations as mentioned therein.

The matter has been further reviewed by the Tariff Committee of this office w.r.t. carrier rates and it has been decided by the Competent Authority to revise the ISD tariff for Landline PCOs / FLPP PCOs / WLL (Fixed) PCOs / VPT (Fixed) PCOs from BSNL Network to certain high cost destinations for **5 (Five) countries** namely **Chad, Italy, Ivory Coast, Kazakhstan and Malawi** as follows:

- 1) Whenever international carrier charges exceed 80% of ISD Tariff, DGM ILD TAX Mumbai / in charges of ILD TAX shall inform BSNL CO [Sr.GM ILD / Sr.GM P&P-CM / Sr.GM (NWO-BB-IN)] so that corrective action may be initiated. Further whenever carrier charges exceed 90% of the ISD Tariff, DGM TAX Mumbai shall block the ISD traffic route and immediately inform the BSNL CO.
- 2) NWO-CFA unit shall issue the new Charge Band wherever required.
- 3) All regulatory requirements may kindly be complied with while implementing the above tariff.
- 4) The circular is issued based on approval of the competent authority in CS-CFA unit File No.22-10/2012-PHB. For any clarification / correspondence in respect of aforesaid tariff, matter may be taken up with CS-CFA unit of BSNL CO New Delhi Phone No.011-23714002.
- 5) Revised tariff shall be implemented w.e.f. **1<sup>st</sup> August, 2014**.

This may be brought to the notice of all concerned and necessary steps may be taken for its proper implementation.
