
Subject: Revision of ISD Tariff for OMAN (Code 96890).

A kind reference is invited to this office letter No. 3-1/2010-R&C[CFA] dated 12-02-2014, 26-02-2014, 03-07-2014, 18-07-2014, 23-03-2015, 19-06-2015, 03-08-2015 & 18-08-2015 carrying approval for revision of ISD Tariff for the destination mentioned therein.

On the change in international carrier charges of **OMAN Code 96890**, the Competent Authority has approved revision of ISD tariff for OMAN Code 96890. The ISD tariff for (i) plan wise with 60 sec pulse duration, (ii) for plans working on MCU basis, and (iii) ISD PCOs as given below:

1. Whenever international carrier charges exceed 80% of ISD Tariff, DGM ILD TAX Mumbai / In charge of ILD Tax shall inform BSNL CO , so that corrective action may be initiated. Further whenever carrier charges exceed 90% of the ISD Tariff, DGM Tax Mumbai shall block the ISD Traffic route and immediately inform the BSNL CO.
2. **The Revised ISD Tariff for OMAN code 96890 shall be applicable w.e.f.16th of Aug 2016.**
3. All other relevant terms & conditions, as mentioned in earlier circulars, remain unchanged.
4. **All regulatory requirements may kindly be complied with while implementing the above tariff.**
