**Subject:- Revision of ISD Tariff for OMAN code 968-790.**

Kind reference is invited to this office letter No.3-1/2010-R&C[CFA] dated 12-02.2014,26-02-2014,03-07-2014,18-07-2014,23-03-2015,19-06-2015,03-08-2015,18-08-2015, 19-02-2016, 10-08-2016 & 26-08-2016, carrying approval for revision of ISD Tariff for the destination mentioned therein.

Consequent upon change in international carrier charges for OMAN code 968-790, the Competent Authority has approved revision of ISD tariff for OMAN code 968-790. The revised rates of ISD tariff for various categories shall be as follows:

1. Whenever international carrier charges exceed 80% of ISD Tariff, DGM ILD TAX Mumbai/In charge of ILD TAX shall inform BSNLCO, so that corrective action may be initiated. Further whenever carrier charges exceed 90% of the ISD Tariff, DGM TAX Mumbai shall block the ISD Tariff route and immediately inform the BSNLCO
2. Revised tariff shall be implemented w.e.f. 10<sup>th</sup> of Oct 2016.
3. All other relevant terms & conditions, as mentioned in earlier Circulars, remain unchanged.
4. All regulatory requirements may kindly be complied with while implementing the above tariff.
