**Sub: - Unlimited Free calling to any network on all Sundays from BSNL landline – regarding.**

1. The Competent Authority on recommendation of Tariff Committee – CFA has approved **Unlimited Free calling from BSNL landline to any network's mobile & landline on all Sundays on PAN India basis w.e.f.15<sup>th</sup> of Aug 2016.**
2. Unlimited Free calling scheme on all Sundays is in addition to free night calling to all networks already being offered from 9PM to 7AM.
3. The introduction of unlimited free calling to any network on all Sundays shall be widely published through SMS on registered mobile number, press release, print & electronic media, CSC, staff & other marketing communication from BSNL CO level, circle level as well as SSA/SDCA headquarter level. All out effort shall be made to acquire more & more landline customers & motivate existing customers to use landline more.
4. The Tariff will be applicable on **PAN India Basis w.e.f. 15<sup>th</sup> of Aug 2016.**
5. The Circle shall ensure to comply with all regulatory requirements
