Sub. Tariff for Prepaid Wireless Broadband Services (WiMAX services) -reg.

Kindly refer to this office order of even No. dated 08.06.2010 and subsequent orders issued from time to time regarding Prepaid Wireless Broadband service (WiMAX). Since, the WiMAX prepaid vouchers communicated earlier could not be implemented due to technical problems, it has been decided by the competent authority to issue the following revised tariff for BSNL WiMAX prepaid services:-

A. Initial Charges at the time of application:

- CPE charges and WiMAX BB Account Creation Charges shall be collected in advance through Demand Note through the local commercial system at the time of application for Prepaid WiMAX BB connection.
- In case of customer having his/her own CPE, only WiMAX BB Account Creation Charges shall be collected in advance through Demand Note through the local commercial system at the time of application for Prepaid WiMAX BB connection.

For Limited Usage Plans, balance usage available if any will be carried forward, in case of recharge within the Grace Period * GP-I (i.e. 15 days). Beyond 15 days (* GP-I), balance usage available if any will not be carried forward, but the customer can recharge his account upto another 45 days (** GP-II). After expiry of the additional grace period of 45 days (** GP-2), the account of the customer shall be deleted from the system.


E. E-mail ID:
