## Circular T&C-CM No. 63/10-11

### Sub. Revision in tariff for Unlimited Home Plan under WiMAX services -reg.

Kindly refer to this office order of even No. dated 22.01.2010 and subsequent order dated 04.02.2010 vide which tariff for Unlimited Home Plans under WiMAX services was issued. Now, it has been decided by the competent authority to revise the Fixed Monthly Charges for Unlimited Home Plans as under:-


- i) The Fixed Monthly Charges (FMC) for Unlimited Home Plan with speed limit of 512 Kbps has been revised from existing Rs.999 to Rs.750.
- ii) Discounted annual option for the above unlimited plan will be Rs.7500 in place of Rs.9990.
- iii) The FMC mentioned above is exclusive of Service Tax, which will be charged as per prevailing rates.

2. All other terms and condition will remain the same.

3. The above WiMAX tariff will be applicable **with effect from 20.09.2010.**

4. This may be brought to the notice of all concerned for taking necessary action in this regard. Proper advertisement as deemed fit may be made to generate adequate response.
