**Sub:- Amendment wrt revised Tariff plan for VOIP “wings” service-Reg.**

2. Now, the Competent Authority on recommendation of tariff committee-CFA has approved tariff for “Wings” service.

Promotional Offers	Proposed plan
Call charges for “wings” customer calling from outside India (International location) to any of the Telephone/Mobile number of Indian network.	Rs. 1.20/- per Minute usage (subscriber need to have ISD facility).
4. *The Circle shall ensure to comply with all regulatory requirements including online reporting to TRAI and also update the Circle website.*
5. **The above instructions are effective after three days from the date of issue of this circular i.e. 13-08-2018.**
