Sub:- Introduction of Special Discounts on 'WINGS' Services for BSNL employees -Reg.

 - i) **BSNL employees to be offered 'WINGS' connection without ISD @Rs.250/- instead of Rs.1099/-annual charges.**

3. **The above instructions shall be applicable with immediate effect on PAN India basis and remain valid up to 30th April, 2019.**
