Sub: Clarification on tariff of NIC and EVDO data card under CDMA services-reg.

Kindly refer to this office order of even No. dated 28.08.2009 and subsequent orders issued from time to time on the subject mentioned above. In response to queries raised by field units, the following clarification is issued.

| Query | Clarification |

| i) Whether existing customer having EVDO data connection (prepaid/postpaid) buying new EVDO data card can use the same connection on the new data card? | i) Yes. The customer can use the same connection on the newly purchased data card. The customer shall retain his existing tariff plan. |
| ii) Whether the customer will be charged Activation charges? | ii) In the above case, no activation charge will be levied for data card purchased from BSNL. The customer will be charged only the sale price of EVDO/NIC data card. |
| iii) What will be the charges in case the customer purchases EVDO/NIC card with RUIM facility? | iii) The customer will be charged only the sale price of EVDO/NIC card with RUIM. No separate charge will be levied for RUIM when the RUIM is bundled with EVDO/NIC data cards. |
| iv) What will be tariff plan applicable to RUIM based EVDO/NIC cards? | iv) The existing tariff plans of EVDO/NIC will be applicable to RUIM based EVDO/NIC card. |

2. This may be brought to the notice of all concerned for taking necessary action in this regard. Proper advertisement as deemed fit may be made to generate adequate response.
