Sub: Tariff for EVDO prepaid plan under CDMA services-reg.

Kindly refer to this office order of even No. dated 28.08.2009 vide which tariff for data usage charges under prepaid EVDO service was circulated. As reported by WIN, different data plans are technically feasible under prepaid EVDO services. As such, it has been decided by competent authority to introduce different prepaid EVDO data plans with the following terms and conditions:-

i) Tariff of prepaid EVDO data plans:-

Sl. No.	Charges	Free usage limit	Charges beyond free limit	Validity
1.	Rs.150	500 MB	Rs.1/MB	30 days
2.	Rs.250	1 GB	Rs.1/MB	30 days
3.	Rs.500	2.5 GB	Rs.0.80/MB	30 days
4.	Rs.750	Unlimited	NA	30 days


- ii) The charges mentioned above will be automatically deducted from the account balance available in the customer's account.
- iii) The bundled free usage is also applicable while in national roaming.
- iv) The data charges while in national roaming is the same as that of normal data charges.
- v) The bundled free usage is to be exhausted within the validity period of 30 days. No carry forward of unutilized free data usage will be allowed after the expiry of validity period.

2. All other terms and conditions will remain same.

3. The above tariff will be implemented with effect from **20.08.2010**.

4. This may be brought to the notice of all concerned for taking necessary action in this regard. Press note and proper advertisement as deemed fit may be made to generate adequate response.

5. This circular is issued based on the approval of the Competent Authority in P&P CM File No.3-42/2010-P&P-CM. For any queries/clarification communication in respect of above tariff, the matter may be addressed to GM (NWP-CDMA), Corporate Office, BSNL, New Delhi.
