Sub: Revision in ISD tariff under Postpaid and Prepaid CDMA services–req.

It has been decided by competent authority to revise the ISD Tariff for specific countries under Postpaid and Prepaid CDMA services as under:



(iv) All other ISD Tariffs and terms & conditions would remain same.

3. This order will be implemented **with immediate effect**. In accordance with 43rd amendment of Telecom Tariff Order issued by TRAI which inter-alia states that a tariff plan once offered by an Access Provider shall be available to a subscriber for a minimum period of six months from the date of enrolment of subscriber to that tariff plan. However, due to technical nonfeasibility to implement different tariffs for new customers and existing customers, it has been decided by the competent authority to offer, as a special case, the pre-revised ISD tariff for a period of six months from the date of implementation of this order, to existing as well as new customers. However, any tariff plan presented, marketed or offered as valid for any prescribed period exceeding six months or as having lifetime or unlimited validity in lieu of an upfront payment shall continue to be available to the subscriber for the duration of the period as prescribed in the plan and in the case of lifetime or unlimited validity plans, as long as the service provider is permitted to provide such telecom service under the current license or renewed license.

4. This may be brought to the notice of all concerned for taking necessary action in this regard. Press note and proper advertisement as deemed fit may be made to generate adequate response.


