## Circular T&C-CM No. 32/10-11

### Sub: Revision in tariff of RCV applicable to prepaid CDMA services -reg.

Kindly refer to this office order of even No. dated 27.10.2009 and order No.3-23/2007-R&C dated 04.07.2008 vide which validity and usage value allowed under different RCVs have been specified. Now it has been brought to the notice of this office that due to launching of special validity vouchers of Rs.110 and Rs.221, the old RCVs with MRP of Rs.109 and Rs.220 are not selling. Since sufficient quantity of physical stock of old RCVs with MRP Rs.109 and Rs.220 are still available for disposal, in order to utilise the existing stocks, it has been decided by the Competent Authority to revise the usage value and validity of RCV denomination Rs.109 an Rs.220 as under:-

- The above revision will be applicable with effect from **07.07.2010**.
- As the features of RCV Rs.110/221 and RCV Rs.109/220 are almost same, after disposal of existing stocks, RCV with MRP of Rs.109 and Rs.221 may be discontinued.
