## Circular T&C -CM No. 101/10-11

### Sub: Clarification on Recharge Vouchers applicable to prepaid CDMA services-reg.

Kindly refer to this office letter of even No. dated 27.10.2009, 02.07.2010 and 29.10.2010 on the subject mentioned above. As per para 3 of order dated 02.07.2010, the RCV Rs.109 and Rs.221 was to be discontinued due the similarity in feature. However, due to rationalization, the feature of RCV Rs.109 has changed from validity voucher to recharge voucher. Based on queries received from field units regarding continuity of RCV 110 and 221, it is clarified as under:-


i) In addition to the existing RCVs with MRP Rs.109 and Rs.220, the validity vouchers with MRP Rs.110 and Rs.221 will also continue to exist in the system.

ii) All other terms and conditions will remain same.
