Sub: Clarification on revision in tariff of data plan under 2G and 3G mobile services-reg.

Kindly refer to this office circular of even No. dated 05.04.2013 vide which tariff of data plan under 2G & 3G mobile services was revised. Based on the implementation issues reported by field units and INs, It has been decided by the Competent Authority to clarify/modify the tariff as under:-

Sl.No.	Issues from the INs	Clarification
i.	As per point (i) and (ii) of the order No.26-17/2009-R&C (Pt.) dated 05/04/2013, the free data is 30 GB or 30,000 MB & 10GB or 10,000MB?	The point (i) & (ii) of the order No.26-17/2009-R&C (Pt.) dated 05/04/2013 is to be read as following:- (i) MRP of Data STV with free data 30,000MB , validity 90 days increased from Rs.3000/- to Rs.3300/- (ii) MRP of Data STV with free data 10,000MB , validity 30 days increased from Rs.1099/- to Rs.1299/-
ii.	In West Zone the Free Data of 2.5GB/ month, 1.5GB /month & 0.75 GB/ month for 12 months in DPV 3299, DPV2299, DVP1251 plans are not technically feasible on monthly basis.	For WEST ZONE only - these annual DPVs can be implemented as:- 1. DPV-3299 - 30 GB (instead of 2.5GB / month) data free with validity 12 months 2. DPV-2299 - 18 GB (instead of 1.5GB / month) data free with validity 12months 3. DPV-1251 - 9 GB (instead of 0.75 GB / month) data free with validity 12 months

2. All other terms and conditions will remain same.
3. This may be brought to the notice of all concerned for taking necessary action in this regard.
4. This circular is issued based on approval of the Competent Authority in P&P-CM cell File No. 3-72/2012/P&P-CM.
