Sub: Revision of tariff under prepaid mobile services –reg.

Kindly refer to this office order of even No. dated 14.03.2012 and clarification dated 20.03.2012 vide which prepaid tariffs were revised under GSM services. Based on feedback received from field units, it has been decided by the Competent Authority to revise the prepaid General plan and also to introduce a new Roam Free plan as under:-

- i) Migration to the Roam Free plan and General Plan will be through the Plan voucher.
 - ii) Commission payable at the time of activation of connection for Roam Free plan and General Plan will be Rs.100 per connection. On subsequent loading of plan voucher for extension of main account validity for Roam Free plan, commission payable will be at par with Top-up.
3. A new Plan Continuation Voucher of Rs.34 with a plan validity of 180 days offering freebies of 50 Min (3000 sec) -On-net + 20 Min (1200 sec) - Off-net voice call to be consumed within 30 days is hereby introduced for extension of plan validity of Per Sec plan, Per Min plan and General plan is introduced. The existing plan vouchers will be used only for migration and plan activation. For special plans including Roam Free plan, extension of plan validity will be through plan voucher only.
 4. In case of Assam, J&K and North East LSAs, instructions issued by DoT/TRAI regarding validity are to be complied with.
 5. All other terms and conditions will remain same.
 6. The above tariff will be implemented with effect from **01.05.2012**. The implementation of the revised tariff is to be made in accordance with 43rd Amendment of Telecom Tariff Order issued by TRAI. Customers may be informed about withdrawal of plan and suitably educated about revision in tariff and to choose the appropriate Plan Voucher/ Plan Continuation Voucher for continuation in their existing plan.
 7. This may be brought to the notice of all concerned for taking necessary action in this regard. Press note and proper advertisement as deemed fit may be made to generate adequate response.
