Ref: Your letter No.22-07/2013-VA-VC I Pt dated 30.09.2014


Kindly refer to your office letter under reference whereby VC status for the purpose of Regular promotion in the grade of PCE(C) was issued by your office with reference to this office letter dated 19.08.2014 (Letter enclosed for ready reference) which is lapsing in this month.

In the meantime an interim order was issued by Hon'ble CAT Guwahati (OA No 40/315/2014 filed by Sh A K Bansal) directing BSNL not to take any action on this office letter dated 19.08.2014 whereby VC status was requested in respect of 15 executives. In OA the applicant has requested for inclusion of his name in the letter dated 19.08.2014 and the matter has been heard by the Hon'ble Court. The decision of Hon'ble court order is expected shortly.

Keeping in view the Hon'ble Court interim order, any action on the VC shall be subject to the outcome of the OA i.e. CPC will be conducted after the issue of the order by Hon'ble court. However to have preparedness for the CPC, it is requested to re-issue the VC status of Executives with reference to this office letter dated 19.08.2014.
