OFFICE MEMORANDUM

Subject : Payment of honorarium to the part-time Inquiry Officers and Presenting Officers appointed by DOT.

From time to time this Department has been appointing part-time Inquiry Officers and Presenting Officers to conduct inquiries as per the procedure laid down in the CCS (CCA) Rules. Since full time Inquiry Officers are not available in this Department to hold such inquiries, the appointment of part-time Inquiry Officers and Presenting Officers is resorted to as has been prescribed by DOP&T. As per the said instructions, honorarium at the prescribed rates are to be paid to the Inquiry Officer and Presenting Officer appointed by this Department. The amount of honorarium to be paid to the IOs/POs was circulated vide this office O.M. of even number dated 2.10.2004. Recently, the DOP&T has issued instructions revising the rates of honorarium to be paid to the IOs/POs vide their O.M. No. 142/20/2008-AVD.I dated 27.7.2009 (copy enclosed).

2. Representations are being received from various sources such as from the Circles/Field Units/Inquiry Officers (Part-time)/Presenting Officer etc. regarding non-payment/delay in payment of the honorarium prescribed by DOP&T. It is, therefore, reiterated that honorarium shall be paid by the respective field offices of BSNL/MTNL/TCIL/ITI etc. to the Inquiry Officers and Presenting Officers, where they are posted, as per latest instructions of the DOP&T dated 27/07/2009

3. Such honorarium shall be paid only on completion of the inquiry and submission of the inquiry report by the Inquiry Officer. Circle/Field units of BSNL/MTNL/TCIL etc. shall obtain a declaration from the Inquiry Officer(s) clearly indicating the date of appointment of the Inquiry Officer/Presenting Officer and the date of submission of the inquiry report etc. and make payment as per the instructions of the DOP&T. The field units of BSNL/MTNL shall obtain necessary certificate/information from the IO/PO directly for deciding the amount of honorarium and no reference in this regard shall be made to this office.

4. The contents of this O.M. may be given wide publicity under intimation to this office.

OFFICE MEMORANDUM

Subject: Grant of Honorarium to Inquiry Officers/ Presenting Officers

The undersigned is directed to refer to this department's OM no 134/4/99-AVD I dated 29th June 2001 and 7th April 2003 on the subject mentioned above and to say that the rates of honorarium payable to the IO /PO in the case of departmental inquiries were last revised vide OM dated 29th June 2001 in the case of serving Government Servants functioning as part time IO/PO and vide OM dated 7th April 2003 in the case of retired Govt Servants functioning as IO. :

2. The existing rates of honorarium as prescribed in the aforesaid OMs was reviewed in consultation with the Ministry of Finance. As a result of review, it has been decided to revise the existing rates of the honorarium, payable, to IO/PO. The rates of honorarium as revised are indicated in the table below:-

Particulars	Revised Rates (per inquiry)
a) Inquiry Officer (Part time Serving Govt Servants)	Rs. 3000/- Maximum Rs.1500/- Minimum
b) Presenting Officer (Part time Serving Govt Servants)	Rs.1500/- Maximum Rs.750/- Minimum
c) Retired Govt Servants as Inquiry Officers	Rs.9750/ (lumpsum) Plus Rs. 1500/- for every additional charged officer.

3 The grant of revised rates of honorarium as above will be subject to the same conditions stipulated vide para 4 of this Department's OM no 134/4/99-AVD-I dated 29th June 2001.

4. These orders will take effect from the date of issue and will also apply to inquiries in progress.

5. This issues with the concurrence of Ministry of Finance, Department of Expenditure, vide their ID no14(4)/2009-EII(B) 14.7.2009.
