

Apex Court as well as migh Court and also is against the Principles of Natural Justice, equity and fair play, thus deserves to be quashed.

6. DETAILS OF THE REMEDY EXHAUSTED -

That the applicant has no other statutory remedy available to him except to approach this Hon'ble Tribunal by way of filing the present Petition.

7. MATTERS NOT PREVIOUS FIELD OR PENDING BEFORE ANY OTHER COURT

That the applicant further declares that he had not previously filed any application, Writ Petition or suit regarding the matter in respect of which this application has been made, before any court of law or any other authority, or any other bench of the Tribunal and nor any such application, Writ Petition or suit is pending before any of them.

8. RELIEF SOUGHT

In the circumstances the applicant most respectfully prays that this Hon'ble Tribunal may graciously be pleased to pass an order to :

- a) Quash the DOT letter No.2-32/2001-STG.II dated 28.07.2008 assigning seniority wrongly to private respondents;
- D) Quash the promotion order dated 29.9.2008 by which 52 SDEs were promoted out of the private respondents on the basis of illegal seniority list dated 27.8.2008;
- c) Direct to the BSNL to fix the seniority of private respondents after the date they qualified the DQE and LDCE against 1/3 quota of vacancy.

- d) Direct to the BSNL to restore the staff no. of private respondents as allotted against their promotion on 2/3 quota or 3/4 quota of vacancies
- e) Pass such other or further order(s) as this Hon ble Court may deem fit and proper in the facts and circumstances of the case.

9. INTERIM RELIEF SOUGHT FOR:

That pending final decision of the present OA it is expedient in the interest of justice that Hon'ble CAT may graciously pleased to pass following interim, order otherwise the applicants will suffer irreparable loss:

- A. Stay further execution and operation of DOT letter no. 2-32/2001-STG.II, uated 28-07-2008 i.e. stay on consequential benefits to the private Respondents based on order dated 28-07-2008.
- B. Stay the further benefits to the 52 private respondents based on order dated 28.07.08 and 29.09.08, like further promotion in higher grade etc.
