

#### JUDGMENT

These Original Petitions relate to appointment to the post of Group-B post in Telecom Engineering Service. The first respondent in O.P.No.21656/01 claimed that he should have been considered against 33.1/3% of the vacanies that had arisen prior to 22.7.1996, when the rules were amended. There was, according to him, a direction from the Supreme per order in Special Leave(Civil) No.26071/95 . in that line. That was not carried out. This resulted in O.A.No.1497/96 and other connected cases in the Ernakulam Bench of the CAT. Taking note of order of the Supreme Court, there was a direction to consider the incumbents concerned, to the vacancies that had arisen before 22.7.96 in accordance with the rules then existed.
