Sub: Seniority List in Sub Divisional Engineer (C) grade- FINAL seniority from sen. number 1121 onwards reg.

- I. Consequent upon formation of BSNL, a seniority list in SDE(C) grade was circulated based on DOT letter No. 33-2/2005-CWG dated 08.09.2005 & 17.05.06 and 19-5/2010-CWG dated: 29.08.2017 & 12.09.2017, in accordance with RR'02 of SDE(C), issued vide no. 20-1/2001-Pers.-II dated 06.03.2002. Assistant Engineer(C)s, who have been permanently absorbed in BSNL from DOT were initial constituents of SDE(C) grade.
- II. Subsequently, Seniority list in respect of BSNL executives was issued vide above cited OM dated 16.06.2006 which was further modified vide OM 10.10.2017 while implementing the direction of Hon'ble CAT PB New Delhi order dt. 27.02.2017 passed in OA No. 1586/2011. The seniority list dated 10.10.2017 consists SDE(C) executives promoted till 03.11.2004 through LDCE quota vide order No. 2-2/2004-CSE dated 16.07.2004 and SCF quota vide order no. 2-3/2003-CSE dated 03.11.2004 with last executive as Sh Krishna J Rao at sl no. 1120.
- III. As per DoTs letter No. 38-1/2018-CWG dated 07.02.2018 a partial revision of seniority list from Seniority no. 901 to 959 was also issued vide this office OM No. 23-1/2000-CSE/Pt. dated 16.07.2018.
- IV. Subsequent to above, PROVISIONAL seniority list dated 05.12.2018 was issued to finalize seniority from 1121 onwards and objections were invited. The objections/representation received have been considered and settled and accordingly approval of competent authority is conveyed for:
 - a) The FINAL seniority list from sen. No. 1121 (Sh C. Kumar Sen) to sen. No. 1671 (Sh Ram Prasad Mukharji) (Annexure-A-II, 12 pages).
 - b) Seniority of Sh Pushpendra Kumar Jain (HRMS No. 199101004) is assigned at seniority slot No. 1075, and Sh Ramesh Chandra-I (HRMS No.198911456) is shifted from slot no 1075 to slot no. 1077, with respect to seniority list dated 10.10.2017. Similarly, other LDCE executives shall shift +2 point downward upto no.1120A in the seniority list dtd 10.10.2017 (Annexure-A-I, 2 pages).
- V. This disposes all the representation received in this regard.


