OFFICE ORDER

Subject: Inter Circle transfer of SDEs (Telecom) – Regarding.

I am directed to refer to this office letter no.:1-3(Misc)/2013-Pers.II, dated 23.09.2013 addressed to circle heads by Sr. GM (Pers) wherein they were requested to relieve the SDEs under transfer to BSNL CO by 30.09.2013.
