The Circle IFA(s) are requested to relieve the Executive(s) under transfer within 15 days without waiting for joining of substitutes in their places and TA/TP MAY BE REGULATED AS PER THE GUIDELINES ISSUED BY BSNL VIDE LETTER NO: 19-27/2002-L&A (PART) DATED 15.04.2004, OM NO.412-10/2009 PERS I DATED 09.05.2012 AND OTHER PREVAILING GUIDELINES ON THE SUBJECT.
- 6. All IFAs may check-up the up-to-date position regarding the vacancies in the grade of AO/Sr.AO in their circles after implementation of the above order and intimate the same to Dy. Manager (SEA), CO BSNL, New Delhi.
