Sub:- Limited Departmental Competitive Examination for promotion to grade of SDE(T) under 33% quota to be held on 04.03.2012- clarification on basis of Column 12,Note 5 of SDE(T) RR regarding.

Reference:- Rectt/TC/X-31/CON/2010 dated 20.1.2012 and 20.2.2012

On the above mentioned subject and reference, It is intimated that clarifications in this regard has already been given vide this office letter even dated 30.7.2010 wherein vide para 1 it was clarified that "LDCE is a fast track promotion based on competitive merit obtained by the eligible officer having completed 3 years of regular service in JTO cadre including pre appointment training period and is no way concerned with seniority of the contending candidates, there is no question of the applicability of senior-junior clause stipulated under Note 5 (column 12) of RRs for LDCE.

Regarding inclusion of training period in the eligibility service, It is submitted that the clarification on this issue has already been issued many times starting in 2007 vide this office letter no. 2-29/2005-Pers.II dated 16.4.2007, in 2009 vide no. 15-12/2009-Pers.II dated 3.12.2009 and finally in 2010 vide even letter dated 30.7.2010. Wherein it has also been explained that the inclusion of training period in the eligibility service to sit for the departmental examination will be governed by DoP&T O M No 14034/5/81-Estt(D) dated 8.3.1983.

It is hereby again clarified that DoP&T OM dated 8.3.1983 will be followed in deciding for inclusion of training period in the eligibility service to sit for the departmental examination and in para 2 of which it is clearly mentioned that training immediately before such appointment would count as qualifying service for the purpose of eligibility for appearing in departmental examination. Hence it is to be followed in true spirit.
