On the basis of their performance in the Limited Internal Competitive Examination (LICE) for promotion from Group 'C' to the grade of JTO under 50% quota for the vacancy year 2015-16, held on 11-12-2016, the Circle-wise Merit lists of candidates, as prescribed vide letter No. 5-11/2009-Pers.-IV dated 20/10/2009 and corrigendum letter No. No. 5-11/2009-Pers.-IV dated 01/11/2011, are given in **Annexure-A**. The marks secured by these candidates, their Roll Nos., HRMS Nos., category and name of the Parent Circle etc as per registration detail have also been mentioned against their names.

2. JTO (T), being a Circle cadre, the Circle(s) is required to prepare the Circle-wise and Category-wise final list from the aforesaid Annexure, as per the vacancy position available with the Circle(s), in accordance with the Circulars issued from time to time and as applicable. The Circle being the Cadre Controlling Authority, will also allot the promotions, postings etc. to the candidates, declared successful, on the basis of the finalised candidates by the Circle, after verifying their service particulars/eligibility etc., as per the provisions of the prevailing Recruitment Rules of Junior Telecom Officer (Telecom) – 2014 issued vide letter No. 5-32/2013-Estt.-IV dated 15/10/2015.

3. A number of candidates had or might have approached various CAT Benches/Courts across the country for the eligibility or otherwise for appearing in the aforesaid LICE and as per the Interim Orders given by the Courts, if any, some candidates might have been provisionally allowed to appear in the said LICE. As such, promotion to such candidates, if any, may be incorporated only after the final outcome of the respective Hon'ble Courts.

4. Accordingly, the marks in respect of the eligible candidates for the aforesaid LICE, verified through ERP by the respective Circles, as per the provision of the RR of JTOT-2014 are being declared.

6. The list has been prepared considering only the Parent Circle of the candidate as per registration detail. In case of already inter-Circle/Rule-8 etc. transfer cases, such candidates may approach to the Cadre Controlling Authority vis-a- vis respective Circles for revision of posting on promotion with respect to the available vacancy.

7. The names of candidates, their Roll Nos., HRMS Nos. and Category have been shown as furnished by the Candidates concerned during Online Registration process/Online examination. All out efforts have been made to prepare the aforesaid list error free.
