Subject: Appointment of observers-2ⁿ Membership Verification (MV) of Executives' Association.

With reference to the subject mentioned above it is stated that all circles may take necessary action for appointment of Observers in sufficient number. While doing so they may consider that the Observers are preferably from amongst:-

- a. absorbed Group A officers/unabsorbed Group A officers working in BSNL/ Group A officers from Term & DoT Cell.
- b. officers of Central/State Governments, Central/State PSUs, Autonomous bodies to create a better perception of independent and impartial observation.

2. Necessary transport facility to the Observers (from other organization/ BSNL) may be provided to enable them to oversee the election in the area under their jurisdiction. An official fully conversant with the topography of the area, the local conditions and the location of the polling booths may also be attached to assist the Observer. It should be ensured that the attached officials are neutral and of impeccable integrity.

3. **Overview of Observer's duty:**

- a) By dint of their seniority and long experience, Observers are expected to be in a position to assist the Management in the conduct of free and fair polls.
- b) They will also oversee the efficient and effective management of the verification process at the field level.
- c) Their role will start immediately after the appointment and continue during the period of the verification till the submission of their report after the counting process is over. They will provide inputs including interim reports when so required considering the gravity of the matter direct to the SR Cell.
- d) They will act as an interface between the Management and the verification machinery & the Associations participating in verification to ensure that the Rules, procedures, instructions and guidelines related to verification are strictly and impartially complied with by all concerned. They can randomly check polling process, dispatch/tracking of ballot boxes, counting of ballot papers including postal ballot. They will visit and monitor all polling stations to see that officers deputed for polling process as per the order are available. Observers may ask for their Identity Card and order of their appointment as Presiding/Polling Officer etc. to see that any unauthorized person is not found at the polling booth.
- e) Their inputs/observations are confidential and solely for the use of the SR Cell and not for any other agency including media.
- f) It is clarified that while the formal report/input/observation sent by the Observers are meant for the use of the Management, it does not mean that the observers will not discuss with the RO/ARO/Presiding Officer/Polling Officer or Counting team, about their observation on various aspects of verification process; this is in order to facilitate midcourse corrections. All the concerned functionaries will explain the reasons and propose corrective actions on the observations of the Observers. They will take such actions as are desired by the Observers to their satisfaction. For this purpose the Presiding Officers will keep a set of guidelines issued by SR Cell for 2ndMV from time to time including a copy of BSNL (REA), Rules, 2014 for ready reference. Failure of the officers in charge of the process to take immediate corrective action or any irregularity or any undesirable behaviour shall be brought promptly to the notice of SR Cell.

g) However, the Observers shall submit their formal reports to the SR Cell and/or CRO only and not to any other person including the functionaries mentioned above.

h) They will oversee that the SOP laid down by MHA, Govt. Of India, in view of COVID-19 pandemic, is properly followed.

i) It should be kept in mind that the objective of the deputation of the Observer is to identify the non-compliances for immediate corrections and to facilitate field administration in ensuring a free and fair poll, apart from submitting factual report to SR Cell of the Corporate Office at the end of the whole process.
