Sub: Continuation of office bearers of Association after retirement regarding

As all concerned are aware, BSNL Recognition Rules of Executive Associations circulated vide no. BSNL/31-2/SR/2009 dated 6th January 2014 have already come into force. Para 7 (3) of the said rule reads -

"The executive bodies of the Associations would be formed from among the 'serving executives' only and thus only serving executives within BSNL would be eligible to be office bearers of the Association at any level/tier of structure. As and when an office-bearer of the Association retires on superannuation or remains no longer in the service of the company, the Association will ensure his replacement within a maximum period of six months from the date of his superannuation or severing relations with the Company."

2. These provisions are brought to the notice of all concerned for strict compliance. The Associations are requested to take timely action for replacement of such retiring/retired office bearers. For any violation of these provisions, the concerned Associations are liable to be declared ineligible to participate in the membership verification.



Sub: Retired executive holding the post of office bearer in Associations- Reg.

It has been observed that some retired executives are holding the post of office bearers in some Associations even after lapse of more than six month of their retirement, which is in violation of the BSNL (REA) Rules 2014. The relevant Rules of BSNL (REA) Rules 2014 are reiterated below:

- 5(2) Membership of the executive Association is open only and summarily to all serving executives in BSNL.
 - 7(3) The executive bodies of the Associations would be formed from among the 'serving executives' only and thus only serving executives within BSNL would be eligible to be office bearers of the Association at any level/tier of structure. As and when any office-bearer of the Association retires on superannuation or remains no longer in the service of the company, the Association will ensure his replacement within a maximum period of six months from the date of his superannuation or severing relations with the Company.
2. All the Associations are requested to strictly adhere to the above Rules and ensure the replacement of retired executive timely.
