
Reference is invited to this office circulars referred above regarding policy for provision of Residential Service Telephone Connections and GSM Mobile Telephone Connections to Executives and Non-Executives in BSNL. With the approval of competent authority, it has now been decided to extend the 3G facility to all officers of the level of JAG and above by converting their existing 2G service mobile connections subject to the following conditions:

- a. The facility will be provided subject to adherence of the prevailing applicable usage limit (excluding plan charges/fixed monthly charges)of the officer concerned.
- b. In case the existing 2G handset presently held by the officer does not support 3G, the cost of handset to be replaced for availing 3G service shall be borne by the officer himself.
- c. The facility of 3G services shall be provided under the following post paid data plans:

Data Plans for officers of the level of JAG and above

Service Area	Data Plan (details available in the respective portal of BSNL/MTNL)
BSNL	MB 650 (Free data usage 2GB/Month, Rs.2/- per MB beyond free limit)
MTNL	3G 750 (Free data usage 1GB/Month, Rs.3/- per MB beyond free limit)


