- 2. It will be seen from the details of ERP that the Hardship Compensation is being paid @ 12.5% of basic pay, without following the condition to a maximum of Rs. 1000/- P.M. w.e.f. 07.02.2004.
- 3. In this connection, the directions of competent authority is hereby conveyed:-
- i) That the disbursal of Hardship Compensation may be regulated strictly in accordance with this office letter dated 24.12.2004 as referred to above applying ceiling limit subject to a maximum of **Rs. 1000 P.M** prescribed by BSNL, Corporate Office.
- ii) That any deviation of Hardship Compensation from these guidelines may be stopped immediately and reqisite recoveries may be made from the illegal beneficiaries, and
- iii) That responsibility of concerned DDOs, who have made excess payments in Hardship Compensation, may be fixed by taking appropriate disciplinary action.
